POLICIES & PROCEDURES

- -All menu items are priced per person unless otherwise noted.
- -All menu items are available when booking at least 10 days in advance. Orders taken within 10 days of event are subject to an 18% administrative fee.
- -All tent rentals need to be submitted at least 14 days prior to event.
- -A final guarantee of guests are due 7 business days prior to event.
- -All rentals are subject to a 20% administration fee if arranged by OVG Hospitality
- -Food and beverage prices do not include management charge* or Connecticut state sales taxes.
- -Rentals do not include Connecticut state sales tax.
- -OVG Hospitality reserves the right to cease alcohol service in catered tents for any reason, at anytime.
- -OVG Hospitality is the exclusive caterer for Pratt & Whitney Stadium at Rentschler Field.
- -Outside alcoholic beverages are not permitted in catered tents
- -Food and beverage cannot be taken out of the tent at anytime
- -The tent closes at the start of the game. Everyone must vacate the tent at that time

BILLING

- -Payment options are credit card only.
- -Payment must be received 5 days prior to the Event Date. If payment is not received prior, food and beverage will not be delivered.
- -All catering is subject to Connecticut state sales tax, unless advanced arrangements are made with the catering department. A valid tax exempt certificate must be received prior to the event to remove sales tax.
- *All catered events are subject to 20% management charge. 10% of this Management charge is distributed to the employee who perform services in connection with the catered event. The remaining 10% of the Management charge is the sole property of the food/beverage service company or venue owners, as applicable is used to cover such party's cost and expenses in connection with the administration of the catered event (other then employee tip, gratuities and wages), and is not a charge in lieu of a tip. The management charge is not a tip, gratuity or service charge for any employee, and no part of the management charge will be distributed (as a tip, gratuity, or otherwise) to any employee who provided service to guests.
